## **General Comments**

Please reference the curriculum framework to create a quality learning environment in both the indoor and outdoor play spaces. It is unfortunate that vandalism is occurring in your outdoor play environment. It may be necessary for materials to be stored inside and taken out each time that the children are going outside. A wagon may assist with the transportation of these items. Learning centres and accessories are required.

As per your quality improvement plan and licensing regulations you must implement a quality environment that is varied and in sufficient quantity for all children present; easily accessible on low open shelves and arranged to allow opportunities for free choice of activities. Open ended materials and equipment must be in sufficient quantity and variety for the size of group and representative for each of the following categories must be present:

- -art materials including loose parts
- -blocks and accessories
- -dramatic play
- -music and movement
- -large muscle
- -manipulatives and fine motor
- -sand and water play
- -puzzles and games
- -materials that support mathematical learning
- -materials that support learning in science and technology

Materials are not limited to use in a particular learning centre only but the centres must be clearly defined. For more information regarding play materials and equipment please consult the Curriculum Framework and reference your 3-step plan issued by the curriculum consultant.

## **General Comments**

Children who were not resting at the time of visit were allowed to engage in tabletop activities. Educators were visibly engaged with the children on the day of this visit.

It is recommended that 15- to 24-month-old children are transitioned into highchairs as they are developmentally ready for it. Educators should be aware of where the children are developmentally and transition them accordingly to the needs of the child and safety requirements such as weight restrictions.
