<p><b>General Comments</b></p> <p>The facility was very clean and organized at time of visit. There were more defined learning centres set up for the children. New shelving has been purchased allowing the materials to be displayed at an appropriate level for the children.</p> <p>The administrator bought all educators planners to journal their planning in. However, educators are still using the older method to plan activities as they transition to the planning method introduced by the curriculum team.</p> <p>The Operator, Administrator and educators must continue working with the curriculum team and strive to maintain all practices that have been implemented throughout the facility. This will be continued to be verified on all monitoring visits.</p> <p>As licensing staff was completing paperwork in the office and the children were preparing to go outside, songs and games were modeled and implemented by the administrator of the facility. Redirecting children's interests during more challenging times is the key to making it easier for both educators and the children. This was great to see. Only positive child guidance was seen at time of visit.</p>
