The school-aged children were just finishing up their snack and were heading outdoors to play. While outside, some children engaged in a soccer game while other children engaged in free play activities in the fenced in playground. The Administrator has replenished the play materials inside and outside for this age group.

The 3/4-year-old classroom children were having their daily quiet time. Some children were sleeping while other children engaged in quiet table-top activities.

The two-year-old children were sleeping and so were the infants.

The couch in the infant room was cleaned and moved away from the chalkboard.

When licensing staff calculated child-to-staff ratio, all classrooms were within child-to-staff ratio according to the Early Childhood Services Act.
