Follow up monitoring visit. All deficiencies are now complaint. A new routine has been implemented in the two-year-old room during lunch time.

Educators in each room were observed sitting with the children while they were eating.

Proper diaper change procedures are now being followed.

Materials have been added to the classroom. Puzzles and magnet sticks were noted in the two-year old room. Nap cots have been replaced, and blankets are now stored separately for each child.

Educators were engaged with the children and were observed offering choices of what activities they would like to do.

I would recommend the books in every room be checked and all book with missing or torn pages be replaced.
