General Comments

Licensing staff arrived at the licensed facility to conduct a license renewal inspection on February 8th, 2023.

The children were still arriving for the day when licensing staff arrived at the licensed facility. Once all of the children arrived for the day, the children had their morning snack which consisted of blueberry muffins, cheese and water.

The educators were engaged with the children at their level throughout the licensing visit. Educators and children were observed reading books, engaging in a craft activity, using crayons, pastels, markers, glue, Q-tips, and paper while others were engaging in a block building activity, using magnetic shapes and trucks and cars.

Licensing staff observed an abundance of evidence of learning posted on the walls for the children to revisit the learning experience. Licensing staff also observed the educators using positive child guidance techniques with the children throughout the licensing inspection.

While inspecting the indoor play environment, licensing staff noted the door jam and door leading to the bathroom was soiled. When this was brought to the attention of the operator, the operator cleaned the door jam

and door right away.

While inspecting the outdoor play environment, licensing staff noted a number of protruding flat-ended bolts, on the under-side of the climbing dome; and, that the dome was paced directly beside the fence which poses as a safety hazard. When this was brought to the attention of the operator, the operator removed the climbing dome from the outdoor play environment.
