General Comments
<p>Licensing staff arrived at the licensed facility on February 21st, 2023, to conduct the license renewal inspection.</p> <p>The children arrived at the centre, washed up and those who were hungry sat down and had their snack. The educator relayed to licensing staff that the children typically play outdoors immediately after being dismissed but on this day the children have been asked not to go on the playground as the playground was very icy and a safety hazard.</p> <p>After the children ate their snack, the children engaged in different activity centers in the classroom. A few children in the group had badminton racquets and passed a balloon around at the back of the classroom, while others engaged in a parachute and ball activity.</p> <p>The educators were very engaged with the children throughout the inspection. Licensing staff also observed the educators using positive child guidance throughout the inspection.</p> <p>The name of the Quality Assurance Monitor and Inspector are posted; however, the New Inspector's name and contact number was not updated.
