General Comments
<p>A renewal inspection occurred today. Children were observed both indoors and outdoors.</p> <p>First room had lots of documentation of children's learning. Interests were flexible to accommodate children's learning. The environment had spaces to inspire a personal sense of wonder. The riddle of the day "You buy me to eat but you don't eat me, what am I?" was displayed and set up prior to children's arrival which is open ended to provide multiple choices, solutions and possibilities for exploration and investigation.</p> <p>The environment or "third teacher" had lots of reading materials, organized and displayed at children's level.</p> <p>The second room had lots of mark making materials. Invitations of stamps were displayed prior to children's arrival that were organized to support maintenance and care.</p> <p>Dramatic play area was natural, familiar real-life materials that represent children's home environments.</p> <p>Cozy corner had lots of reading materials, pillows, cushions and stuffed animals for children that were comfortable and assessable.</p> <p>Educators asked questions to prompt children to talk and find solutions to disagreements and conflict. They listened carefully and gave them time to think and express what they are feeling. Using positive language and being respectful to each child validates and supports each child's wellbeing and feelings.</p> <p>Healthy proper handwashing procedures were followed. All staff and children's files were observed and complete.</p>
