| Comments: In the baby's room, two children passed the two hours of rest period. Inspector had a discussion with the operator and staff to remind them that the rest period shouldn't exceed two consecutive hours unless there is a written request from a child's parent or guardian to extend the length of time. During the follow-up inspection visit, all children in the baby room were up and having a snack. The educator shared that since the inspection they have been slowly waking up children when they've been napping for two hours. Deficiency is now compliant. | | | | | | | |
