Comments: During the renewal inspection, the inspector observed a hole in the wall in the washroom, leaving drywall exposed. During the follow-up inspection, inspector observed that this was not repaired. The operator must ensure that the hole in the wall is repaired in order to ensure the indoor play is maintained clean and safe.			
48(2) An operator of a licensed facility may supply food to a child receiving services at the licensed facility that a parent or guardian of the child brings from the child's home if the food is labelled with the child's name and refrigerated, as required.	48(2)	Oct 31, 2023	Nov 16, 2023
Comments: A discussion was had with staff, who indicates that a reminder was done with parents to ensure that all food brought from home is labelled with the child's name. Deficiency is now compliant			
50(1) An operator of a licensed facility shall maintain a chronologically filed daily incident log relating to the health, security and well-being of the children receiving services at the licensed facility.	50(1)	Nov 03, 2023	
Comments: 2 of the verified incident logs do not indicate the time that the incident occurred. The operator must ensure that all required information is recorded on the logs, including, child's name, date, time, injury and care provided, description of circumstances and parent's signature.			

### General Comments

Regulation 11(a) : An educator's staff file was not on-site during the inspection. When the staff file was brought on-site, Inspector observed that the educator's first aid and cardiopulmonary resuscitation certificate has expired. Administrator must ensure that the educator obtains required certification and that a copy of their certificate is placed in their file.

Regulation 12(2): An educator's staff file was not on-site during the inspection. Therefore, a copy of their criminal record check and/or vulnerable sector check as well as a check with the Department of Social Development was not on-site. Staff's file was brought to facility during the inspection.
