General Comments

Quality Assurance Monitor discussed how the rooms are divided with staff and administrator. Groupings must not exceed the requirement for two educators. In a school age program this is 30 children for every two educators. Staff must be made aware of these regulations and a system created to ensure the groupings do not exceed 30, and staff are aware of which children they are responsible for.
