Comments: During the monitoring inspection, the Quality Assurance Monitor observed that one new staff file did not contain a copy of the confirmation of enrollment to the 90hours training. The administrator was able to print a copy during the inspection and has inserted a copy in the staff records. Deficiency is now compliant

Comments: During the monitoring inspection, the Quality Assurance Monitor observed one staff file that was missing their signed statement regarding obligations under the Act and licensing regulation. The administrator met with the staff member and a signed copy of the statement was added to the staff records. Deficiency is now compliant			
31(3) An operator shall maintain the outdoor play area of a licensed facility to ensure the safety of the children.	31(3)	Aug 02, 2024	
Comments: During the inspection, the Quality Assurance Monitor observed that there were 3 broken toys in a toy storage bin in the school age play area. The administrator stated that they consistently do verifications to dispose of broken objects and that a verification was completed recently. The administrator confirmed that another check would be conducted. A confirmation that the objects have been removed can be sent to the Quality Assurance Monitor as proof of compliance.			
31(4) An operator shall ensure that the outdoor play area of a licensed facility (a) includes a shaded area that is at least 10% of the outdoor play area.	31(4)(a)	Aug 23, 2024	
Comments: During the inspection, the Quality Assurance Monitor observed that the large school age area did not contain an area providing shade as per Regulation. The administrator shares that when they had opened, they had planned for the wooded area to serve this purpose however the children are not in that area on a day-to-day basis which means that this does not meet the intended Regulation. The operator must add a shaded area in the school age outdoor area. Photos of the shaded areas can be sent to the Quality Assurance Monitor as proof of compliance.			

General Comments

The Quality Assurance Monitor is onsite for a monitoring inspection. During the inspection, the Quality Assurance Monitor observed the outdoor play area, the outdoor play area material and equipment, staff records and positive child guidance.

The Quality Assurance Monitor observed children engaged in a variety of indoor activities. The educators were observed engaging in conversation and playing with the children.
