During the inspection, the Quality Assurance Monitor observed an educator on the floor with 5 infants while the other educator was assisting an infant in the bathroom. The Quality Assurance Monitor observed the educator on the floor restraining an infant by placing her hands on the child's back to get the child to stop moving. The educator then flipped the child onto their back while holding onto the child by the legs and held the child down. The Quality Assurance Monitor instructed the educator to stop restraining the child and that this was not an acceptable practice. The QA Monitor advised the Directors and instructed them to address with the educator and inform the parents immediately. Director to review Section 8.2 of the Operator Manual Supervision and Child Guidance with the educator, must create a written plan that will ensure a safe environment and provide a copy of the plan to the QA Monitor no later than end of day June 8, 2022.
