Comments: A copy of a first aid certificate is missing in one staff file. Operator retrieved the certificate and added it in the file. Deficiency is now compliant.			
29 An operator of a licensed facility shall ensure that the traffic area and the outdoor walk-ways of the licensed facility are free from obstructions and hazards.	29	Aug 12, 2021	
Comments: Several cots and two blackboard easels are leaning on a wall in the hallway next to the downstairs bathroom. A wooden panel approximately 3 feet high is used to keep children away from toys during deep cleaning periods. These items need to be stored in a secure manner to avoid them from tipping and to provide a secure environment for the children.			
31(8) The outdoor play area of a full-time or part-time early learning and childcare centre at which services are provided to infants and children of another age group shall (a) include a separate area for the infants, or (b) be used by the infants and the children of another age group at different times.	31(8)	Aug 12, 2021	
Comments: Infants were outside in the playground at the same time as other age groups. Operator will have to schedule different plays time for infants or add a fenced in area.			
39(2) A licensed facility shall have a separate locked storage space that is inaccessible to the children for each of the following: (a) toxic products, chemical products and cleaning supplies;	39(2)(a)	Aug 16, 2021	
Comments: Some toxic products (Lysol wipes) are stored in a closet that does not lock. Other products (laundry detergent, Clorox, Lysol) are stored in a storage that locks with a sliding lock. The lock must be a key lock.
