Comments: 2 of the 10 children's profile verified during the renewal inspection indicated a life-threatening allergy that requires a EpiPen. These life-threatening allergies are not posted in the licensed facility. Life Threatening allergies and a description of that allergy needs to be posted in a clearly visible and prominent place in the licensed facility.

Comments: Only 1 out 2 EpiPens required to be on site for 2 children who have life threatening allergies in the licensed facility. Medications used for anaphylactic shock needs to be stored safely and easily accessible at all times for all children with a life-threatening allergy.

Comments:	Allergy information for 2 children that have life threatening allergies is not posted in the food preparation area. Operator must ensure all allergies are posted in the food preparation area.							
General Comments								

During the inspection, the inspector observed outdoor play, lunch time, nap time and various indoor activities being played in each classroom. Positive interactions between the educators/operator and the children are observed for the duration of the inspection.

Discussions with the operator for the children who have life-threatening allergies listed in their child profile need to be updated every year. When changes to life threatening allergies occur, child profiles need to be updated immediately. Recommendations to the operator to verify all children's profile to ensure the information is accurate and updated. The operator and the parents should review the child's profile annually.
