General Comments
During my unplanned visit in the morning, I observed compliance with the ratio for all age groups present. In addition, young children are not mixed with other age groups. The following elements are observed during my visit: <ul style="list-style-type: none"> - Verification of one new file for staff members and updates to other required information. - Personal belongings are separated and clearly labelled with each child's name. - Toxic, chemical, and cleaning products in the daycare are stored in a locked area and kept out of children's reach. - Appendices 11 and 12 were completed and signed by the parents. A hand foot mouth notice of illness was displayed at the daycare entrance. - Weekly or monthly planning was completed, or adjusted as needed based on the group, and documentation

was maintained in a portfolio for each room.

During the observation of snack time, which was provided by the parents, it was noted that the children would not be going outside due to the temperature (-22°C with wind chill) and that one of the infants was sleeping.
