<p><b>General Comments</b></p> <p>On the day of my monitoring visit the children were just finishing snack. The 2-year-olds were getting ready to go outside, washing hands, cleaning up and having their diapers changed. Although this group of children were all 2 years old, their behaviours seemed much younger, and they needed a lot of care. One of the children was having a difficult time adjusting to childcare and although staff held her and tried to comfort her, she cried off and on for most of the morning. When the group went outside to the smaller preschool play area, they were difficult to engage in any play activities, and their educators spent a lot of their time redirecting them and encouraging them to play cooperatively. Some brainstorming was done with the site educator on possible solutions to these issues and it was recommended that special toys just for this group be prepared such as small brooms, dolls, blocks and play doh to be brought outside to encourage more engagement and cooperative play. The educators are doing their best to meet their individual needs and give them one on one time, but with a 2 to 10 ratio this is not always possible. The 2-year-olds went in a bit before the older group, had their lunch and everyone napped.</p> <p>The mixed preschool group of 3- to 5-year-olds was very active. Thier circle time consisted of very active singing, acting and dancing and the children were very engaged. This group played outside in the play area closest to the center and they ran up and down the climber, drew on it with chalk, put on a singing performance based on popular K-Pop songs, kicked around a ball and a few drew and coloured at the outside tables. The shade is also up in this are as well. The site coordinator played a game with the older children which they really enjoyed. The children have marigold that they are caring for and seem to be enjoying that as well.</p> <p>The environment is bright and clean and well set up for each age group. The Parent Board, attendance, cleaning lists, fire drills and child and staff files were all complete. The staff are all kind and patient with the children and work with them to develop trusting and respectful relationships.</p>
