## **General Comments**

Licensing staff spoke to infant room educators, and they stated that they are being more intentional about taking the infants outside. It is understood that it can be challenging at times to get infants outside especially when they are sleeping on demand however as discussed one educator can stay in with 3 infants while the other takes 3 outside.

A pre-planned program and documentation are now evident in the infant, 2-year-old and 3-year-old room. The educators have implemented an organized method to display the children's learning and are now providing proof of preplanning. Please ensure that this continues and is kept on file for verification by licensing staff.

As discussed with the operator, the 4-year-old room requires more support. The educator was not able to provide proof of a pre-planned program or documentation of the children's learning. The Operator forwarded pictures to licensing staff after this visit. Please reference the New Brunswick Curriculum Framework and provide a curriculum that is child focused. I will refer this room to the Quality Assurance Monitor for support going forward.
