Comments: When Quality Assurance Monitor arrived on site, she observed an educator drink coffee in the play area. Hot beverages are not permitted in areas occupied by children. The educator in question disposed the hot beverage immediately. Deficiency is now compliant			
9(1) The child-to-staff ratio is one educator for each of the following groups of children of the same age receiving services at a full-time or part-time early learning and childcare centre: (a) three infants or fewer; (b) five children or fewer who are two years of age; (c) eight children or fewer who are three years of age; (d) ten children or fewer who are four years of age or older, but who are not yet attending school; and (e) 15 school-age children or fewer.	9(1)	Dec 12, 2023	Dec 12, 2023
Comments: At the time of the inspection, one of the educators told the Quality Assurance Monitor that 14 children were in his care. However, after counting the children and referring to the attendance record sheet, the Quality Assurance Monitor informs the educator that only 13 children were present. In order to provide appropriate supervision, educators must know how many children are in their care at all times. The QA Monitor had a discussion with the administrator. Staff members must be reminded to conduct frequent head counts. Deficiency is now compliant

<p>The Quality Assurance Monitor is on site for a monitoring inspection,</p> <p>During the visit, the following elements were verified:</p> <ul style="list-style-type: none"> - child to staff ratios - incident records - washrooms <p>All minor incidents are properly recorded, documented and signed by parents so that they are well informed of any incidents that may have involved the child while at the facility.</p> <p>There are sufficient and safe washroom facilities to meet the needs of the number and ages of children enrolled in the facility.</p>
