General Comments
<p>Licensing staff arrived at the facility at 1pm. Upon arrival, the children were observed napping on their cots. The spacing of the cots was appropriate. The operator and quality assurance monitor discussed the annual renewal application during this time.</p> <p>Later, as the children started waking up, the operator was observed going over to the children and encourage them to use the washroom once they were ready. The children used the washroom and then were prompted to pick out a book and read independently in their cots. The operator was in touch with the children's needs by offering to adjust the children's socks and help them put their shoes on. Once all children were awake, the operator was heard asking how the children slept while guiding a group to the washroom. During this time, another educator was heard prompting the children to put their blankets away and help put away the cots. The educator was heard praising the children for helping.</p> <p>All hands were washed before sitting down at the snack table to eat. The educators helped the children open their afternoon snacks while sitting at the table with them. Conversations were heard while the children ate their afternoon snack. Once finished, the children were prompted to put their lunch boxes in their backpacks and then wash their hands. The children's personal belongings were all properly stored in their cubbies. During this time, an educator was observed setting out a large Lego bin, a butterfly craft and opening sand and bug themed sensory tables. The children were observed engaging in free play activities. An educator was heard inviting the children to participate in the butterfly activity while supervising a group at the activity. The operator was observed sanitizing the snack tables, sweeping the floor and then joining the children engaged in free play activities. The operator was observed sitting on the floor with a group of children playing with Legos.</p>

General Comments

The indoor environment was clean and well organized. A variety of natural based materials were observed in the indoor play area. Themed books were observed in the corresponding area to allow the children to make connections. Pictures and laminated pictures of places in the community were observed. Recent artifacts and learning stories along with pictures were posted in the indoor environment. A large family tree, calendar and provocations were posted in a section of the classroom that resembled a living room.
