General Comments

A renewal inspection was conducted today.
The children were observed during inside play, outside play (two fire trucks visited), lunch, and quiet time.
The children were observed pretending to be firefighters and putting out "fires" inside the childcare facility after the visit from the firefighters.
Recommending that when it is raining to ensure that the water tables are tipped on their side and containers

with toys outside have the covers securely attached to prevent the accumulation of standing water. Educators were observed speaking kindly and appropriately to the children, comforting as needed and re-directing behaviours.
