General Comments
<p>The Quality Assurance Monitor is on site for a monitoring inspection. The Quality Assurance Monitor was able to observe the children during their indoor free play. Deliberate planning and documentation were observed as there were several visual documentation in the classroom that clearly illustrated the children's learning. The classroom had been arranged to encompass the children's current experiences and explorations. The planning demonstrated that the children are currently exploring a fall theme. A sensory bin with oats, apples and pumpkins was made available to the children to explore in sensory play. The children's displayed artwork featured pumpkins and apple trees and books in the reading area included books about Fall.</p> <p>During the inspection the children asked the educator if they could paint. The educator immediately set up a table for water paints and the children were given the opportunity to participate in messy play while exploring their creativity. The children were using the paint on paper, paper plates and their hands. The educator let the children explore the paint in their own way.</p> <p>During the inspection, the Quality Assurance Monitor had a discussion with the operator/educator regarding inclusion and the tools that are available when extra support is needed. The operator/educator shared that it can be difficult in a ELC Home since the educator is alone and does not have access to immediate support on challenging days. The Quality Assurance Monitor and the Operator/Educator had a discussion regarding the upcoming professional development opportunities that are being offered and that could be beneficial in regard to inclusion. The Quality Assurance Monitor has also encouraged the Operator/Educator to share with the ASDE Team professional development opportunities that the Operator/Educator would recommend in regard to ELC Homes and their challenges. The Operator/Educator has validated that dismissals are not taken lightly and that they will ensure that several steps are taken and appropriate documentation and adjustments are made before resorting to dismissals. The Operator/Educator has confirmed that they would reach out to the Inclusion Support Program should they feel that they are in need of extra support to see what options are available.</p>
