## **General Comments**

A monitoring inspection occurred today.

During the inspection, the Inspector observed the children in outside play, inside play, lunch and nap/quiet time. Discussions were had regarding Public Health Standards around chicken and baby chicks in a childcare centre.

These are not permitted around infants and preschool age children.

Discussed diaper changing procedures and Educators are to ensure to follow diaper changing guidelines. Bleach/water solution is to remain on the surface for 2 minutes before wiping clean and permitting the next child to be changed.

In in the Infant room, the children were observed having lunch and preparing for and having nap/quiet time. Daily Information Sheets and attendance records were reviewed by the Inspector and verified complete. Documentation on the wall in the infant room depicts the children engaged in learning and play. Inspector

observed pictures of children playing dress-up, looking at and having pictures books read to them and playing the ball pit.

In the four preschool rooms, the children were observed having lunch with their peers and educators, playing outside in the fenced in play area while some children in this age group where resting or sleeping on the cots in their respective learning environments with their educators. Children's art and learning were observed posted on the walls of the indoor learning environments. Children's current interests such as apple picking is taking shape in the room. Inspector discussed with the Educators who indicated that this interest began when one of the children went apple picking last weekend.

The outside play areas for the infants and preschool children have all have extensive changes to them. Wooden cozy corners, wooden covered sandboxes, swing sets, wooden climbing structure and a wooden hut/cabana have been added as well as numerous toys. Inspector observed the children in the outside play area actively engaged in activities in this area.

A review of all new staff files occurred, and discussions were had with the Administrators regarding Social Development Checks for staff when the leave/quit a centre and come back. This must be treated as a new staff and a new check with the Department of Social Development is required
