<p>The Quality Assurance Monitor is on site for a monitoring inspection. During the inspection, the Quality Assurance Monitor has been able to observe the children during their free play in the gymnasium, during lunch time and nap time.</p> <p>During the inspection, the Quality Assurance Monitor verified the attendance records and children files. The administrator has notified the Quality Assurance Monitor that the school age children are presently in the community centre for the summer as part of a summer camp program. A reminder was given to the administrator about making sure that the child files (for the school age children that may be on site during the morning or at the end of the day while waiting to be picked up) be at both location.</p> <p>The Quality Assurance Monitor also had a discussion with the administrator regarding a potential relocation opportunity. The Quality Assurance Monitor has reminded the administrator that an application for change will need to be completed and sent to the QA Monitor and a fire plan and health plan review will need to be completed.</p>
