General Comments
<p>A follow up to the renewal inspection occurred today.</p> <p>The children and educators were observed during inside play, lunch nap/quiet time and getting ready for outside play.</p> <p>Discussed with Administrator 1/2 doors between the infant/two's room and the two's/three's room. Discussed adding a sink and change table to the infant room, however due to size of the room this is not possible as room measures for six children and there is no more space available to add this. Discussed educators taking one child at a time to change them and then coming right back. Also ensuring that there are two educators in the room when this occurs.</p> <p>Educators were observed having positive interactions with the children in their care, tending to their needs, comforting them when a child became upset and redirecting children when arguments over toys occurred.</p> <p>Facility is recommended for license renewal, pending the recommendation from both Fire and Public Health.</p>
