General Comments

A Monitoring Inspection was completed this morning. Children were observed inside, during free play and snack, and during outside play.

All rooms contained several forms of documentation - learning stories, photos, and children's artwork. All rooms also had several well-defined learning / play centers - arts & crafts, cozy reading area, building, and dramatic play.

Infants were observed finishing up their snacks. After snack, infants were observed outside, in the infant play area. Infants were observed playing with bubbles and sitting in and driving toy vehicles.

2's Room - Children were observed playing at a Tuff Tray. The Tuff Tray had water with red food coloring, and a big ice block, which had frozen red toys inside. Children were observed using materials to try to get the frozen toys free. Children were also observed during outside play - playing with toy vehicles, sliding, playing in the sand box, and chasing bubbles.

3's Room - Children were observed playing with blocks and toy vehicles. Children were also observed singing, and making music, with instruments. Children were observed dancing. Children were observed lining up at the door and transitioning to outside play. While outside, children were observed playing with toy vehicles, sliding, playing in the sand box, and chasing bubbles.

4's Room - Children were observed playing with hot wheels. Children were observed setting up car ramps and placing the ramps in different areas of the room, to see which set up was the fastest. Educators stated that the children are very interested in hot wheels.

School Aged - Children were observed finishing their snacks. After snack, children were observed sitting on the floor with their educator, painting, on a large piece of paper.
