<p>General Comments</p> <p>A renewal inspection occurred today.</p> <p>The children were observed during inside free play, lunch, nap/quiet time, afternoon snack and outside play. Handwashing and diaper changing routines were also observed during the inspection.</p> <p>Recommending that the pea gravel be raked under the slides in the outside play area.</p> <p>In each of the learning environments the children's learning is documented and displayed on the walls using a variety of documentation. Pictures, learning stories, webs, etc.</p> <p>Discussed with Administrator Professional Learning hours for staff as two staff are required to complete their PL prior to the license expiration of November 30, 2024.</p> <p>Educators in all the rooms were observed down on the floor engaged with the children in their learning and play.</p> <p>Positive child guidance was observed as well as positive interactions between the Educators and the children.</p>
