A renewal inspection occurred on October 15, 2025.

The children were observed during multiple times throughout the day: morning snack, transitions, lunch, nap/quiet time, afternoon snack and outside play.

In the infant room, Inspector observed that the children's learning is documented and displayed on the walls. Inspector observed pictures of the children playing in the sandbox, pictures of the children exploring leaves in the tuff tray, finger painting, planting flowers in the dirt, looking at books, playing with trucks and painting with pinecones. Inspector also observed documentation displaying the children's new words they are learning. In the 2's, 3's and 4 year old rooms, Inspector observed the children's learning documented and displayed on the walls. In the 4-year-old room, the children's current interests is Skeltons. When the educator was asked where the interest came from, they indicated from decorating for Halloween. It has since evolved into learning

about body and body movements such as jumping.  Discussed with the Administrator the need for more outside materials. Recommending trucks such as Tonka due to their durability. Discussed adding pylons to the parking lot adjacent to the front door so the school-age children could utilize this area for chalk, skipping, ball hockey etc.
