General Comments

Monitoring Inspection:

Children observed during snack, transition times, indoor play and outdoor play this afternoon. Children engaged in a variety activities including; story time, mud kitchen play, gross motor play and art.

Room Six:

General Comments

Smooth transitions to the outdoor play area were observed. Educators were observed encouraging children to get dressed for outdoor play independently.

The learning environment has a variety of types of documentation posted that highlights the children's learning, experiences and interests. This group is currently interested in birds (mostly pigeons) and plants.

Items the children and educators have collected from nature have been added to the indoor environment for the children to expand on their interest in their collections.

Educators were observed setting up meaningful invitations at the end of the day to ensure the environment is ready for the children when they arrive in the morning. This creates an inviting and engaging environment that welcomes the children upon arrival.

Room Seven:

Children and educators observed during the transition to outdoor play and snack time. This group enjoyed their snack (Pumpkin Loaf) in the outdoor play area this afternoon as, the weather was beautiful. Hand washing routines were observed before snack and after washroom routines.

Documentation is posted in the indoor play area that supports the children's experiences and learning. This group is currently doing a book study on Dr. Suess and just completed one on Robert Munsch.

Educators were observed setting up meaningful invitations at the end of the day to ensure the environment is ready for the children when they arrive in the morning. This creates an inviting and engaging environment that welcomes the children upon arrival.

Next steps: Dramatic play area appears crowded and unorganized. How can you make this area inviting for the children?

The after school program is not currently operating. This environment is currently being used as a break out space for the preschool children.
