Prior to going outside the educators set up invitations for learning for the children to be able to engage with when coming back from outside play.</p> <p>The children's learning is displayed on the walls in the form of art, learning stories, pictures and captions.</p> <p>The educators were observed having meaningful and respectful conversations with the children in their care and re-directing behaviours appropriately.</p>
