A renewal inspection was conducted today. The children were observed during story/circle time, preparing for a walk/outing, handwashing, lunch and quiet time.

The learning environments in each of the areas on this license have a wide variety of open-ended materials for the children to interact and engage with. Prior to going outside the educators set up invitations for learning for the children to be able to engage with when coming back from outside play.

The children's learning is displayed on the walls in the form of art, learning stories, pictures and captions. The educators were observed having meaningful and respectful conversations with the children in their care and re-directing behaviours appropriately.
