## General Comments

### Monitoring Inspection:

Children and educators observed engaged in a variety activities including outdoor play, songs and stories, open-ended art opportunities and building with blocks and loose parts. Educators observed at children's level engaging in meaningful conversations.

Each environment has documentation that supports the children's current interests (artists, hockey, pets, snow and animals). Documentation in a variety of forms - webs, photos, learning stories, prompting questions, ongoing projects and open-ended art pieces have been displayed throughout each learning environment. Next steps - adding connections to NB Curriculum Framework to documentation.

The three/four room is currently discussing different artists and the materials /techniques they use. Art materials and books to support this interest are added throughout the room. An ongoing art gallery project is displayed throughout the facility. Plans have been made to have an Art Gallery open house for families to attend.

Each environment was observed to have a variety of interesting materials for the children to explore. Invitations have been purposefully planned and set up for the children throughout the environments. Dramatic play clothes currently stored in baskets. How can you create a way to store costumes and props that is inviting and more accessible?
