support the children's current interests (hair and make-up, Valentine's Day, gross motor activities, and outdoor adventures).

Educators observed sitting with children during lunch time and engaging in meaningful conversations. Macaroni, hamburger and tomato sauce was served for lunch.

Handwashing routines observed during washroom routines, after outdoor play and before lunch.

Children were observed to choose where they set-up their cots for rest time. Educators dim the lights, put on soft music and set-up quiet activities for children during rest time.
