open-ended art opportunities, dramatic play, sensory opportunities and building with blocks and loose parts. Educators observed at children's level engaging in meaningful conversations and asking open-ended questions.

Each environment has documentation that supports the children's current interests (tracks, bake shop, vehicles, obstacle courses, babies, peek-a-boo and sensory play). Documentation in a variety of forms - webs, photos, learning stories, and open-ended art pieces have been displayed throughout each learning environment. Next steps - adding connections to NB Curriculum Framework to documentation.

Room #5:

Children observed to be invited to join morning meeting if they choose to. Children were free to explore the environment while morning meeting happened. Children were observed joining in, choosing where they were comfortable and choosing when they were ready to move onto a new activity. This is part of valuing children and their choices.

Each environment was observed to have a variety of interesting materials for the children to explore. Invitations have been purposefully planned and set up for the children throughout the environments. Materials have been added to each environment that support the children's interests. (Pastry blocks, pylons, sensory globes, gross motor steppingstones).
