When inspector arrived. children were observed participating in painting and free play in each learning environment. Areas in each room were flexible to accommodate children's emerging interests. Materials are natural, familiar, real-life materials that represent children's home environments. Indoor props/materials are supportive in different modes of communication to represent children's thinking and understanding. Educators were observed playing, engaging and participating in children's play indoors and outdoors.</p> <p>Inspector made recommendation for shelving in each learning environment to be de-cluttered to ensure safety of children.</p> <p>Inspector also talked to admin about rugs on order for each that need to be replaced. Inspector will check at follow up.</p> <p>All checks were complete. All staff files were observed and complete, as well as random review of children's files were observed and complete.</p>
