The children were observed in the outdoor play area and exploring the woods in behind the play area. A variety of materials have been added to the outdoor environment that encourage children to dig, dump, fill and build.</p> <p>Each indoor play area is set-up with a variety of materials for the children to explore each interest center freely. Materials and documentation have been added that support the children's current interests (superheroes, food, the five senses, bugs, pets, and climbing). Documentation is displayed throughout out each environment that includes connection to the NB Curriculum Framework.
