Monitoring Inspection:

Children and educators observed engaged in a variety of activities outdoors this morning including sprinkler play, gross motor play, sand play and exploring ride on vehicles. An invitation is set up for the children to

explore a block of ice with sea creatures frozen inside, a small group of children worked together to get the animals out with tools and water.

The indoor play areas appear to be well maintained and organized. QA Monitor discussed setting up invitations throughout the environments for children to explore at arrival and when they come in from outdoor play. QA Monitor left some ideas/examples of how this could look with administrator on site.

Purposeful planning is evident through documentation displayed throughout the learning environments that supports the children's current interests (music and movement, bugs, worms, taste and smell, pets and animals, sensory play). Each child's learning and experiences are documented in their individual portfolios.

Handwashing routines observed during washroom routines and before lunch.

Monthly fire drills are documented.

New staff file (6) review was completed, all required documents are in place.
