<p><b>General Comments</b></p> <ul style="list-style-type: none"> <li>-Afternoon visit to the learning center for an unexpected monitoring inspection</li> <li>-Ratio was respected during the visit</li> <li>-Daily routine into the center includes; Outdoor play time at least once every 4 hour block time, when the weather is permitting. Meal and snacks are served at the recognized hours and a daily rest period that meets the children's needs.</li> <li>-Outdoor play area has at least 10% shade and is maintained safe and free of hazard</li> <li>-Outdoor play area consists of more than one surface to permit different types of play</li> <li>-Outdoor material is varied and in sufficient quantity for all children present. Operator is presently rethinking the outside space a lot of material and structures will be added in the next couple of days.</li> <li>-Children's guidance is done in a respectful and positive way</li> <li>-Toxic products, and cleaning supplies are locked and inaccessible to children</li> <li>-Management of potential illness forms are completed as required, discussion with the operator on appendix 11 &amp; 12 in the operator's manual.</li> <li>-Parents are advised when a child has a communicable disease or illness, center does use the notice of illness form (appendix 13, in the operator's manual)</li> <li>- It was asked to review the parent's handbook to confirm that the information contains in appendix 14 (Managing illness in ELC facilities- parent's/guardian's role) is found into their guide. If not, it is recommended that a copy of the appendix is given to parents.</li> <li>-Monthly emergency evacuation and fire drills are completed, smoke alarm, smoke detectors and fire extinguisher inspection and maintenance are recorded.</li> </ul> <p>Observations: When arriving at the center all children were done with napping, they were outside playing in the sand box. They played outside until I left.</p>
