<ul style="list-style-type: none"> <li>-Early-morning visit to the establishment for an unexpected monitoring inspection</li> <li>-Ratio was respected during the visit</li> <li>-Posted on top of the cubbies are the following documents: The license, inspection report, orders for compliance, daily routine, evacuation procedures, name of administrator, name and telephone number of QA Monitor and inspector</li> <li>-When it applies a notice to inform parents of the existence of a communicable disease is posted on the front door</li> <li>-All children's files have a signed and dated child's profile and consent form</li> <li>-A reminder was given to redo the criminal record check for one associated person since it will expire in two months</li> <li>-The daily information sheet for infants (0-24 months information about the child's mood, eating schedule, rest time, diaper changing) is completed every day and stored in the child's file</li> <li>-The following administrative records are maintained on site: Financial records, daily attendance of children and staff, menus and any substitution, monthly emergency evacuation fire drills, smoke alarm, smoke detector and fire extinguisher inspection and maintenance records</li> <li>-Monthly emergency evacuation and fire drills are completed</li> <li>-During the visit, it was observed that the operator is engaged with children at their level providing support and having conversations. Open-end questions are asked and guidance is provided in a respectful and calm way</li> <li>-Children's indoor play area is safe and clean.</li> <li>-Material and equipment proposed to children in the indoor play area are easily accessible on low, open shelves. It is varied and in sufficient quantity for all children present.</li> <li>-Toxic products, and cleaning supplies are locked under key and are inaccessible to children</li> <li>-In a family dwelling firearm are locked and inaccessible to children</li> <li>-Each child has an easily accessible space to store their personal belongings, which is labeled with their name and used only for the intended child.</li> <li>-Pacifiers do not have a neck string</li> <li>-Addition were added to each zone in the playroom, it created a more inviting and engaging environment for the children and provide a variety of opportunities for creative play and learning.</li> </ul>

General Comments

-In the playroom and the entrance evidence of purposeful planning based on children's interest and learning, photos and learning stories were posted.

Observations: When arriving at the center children were getting ready to go play outside, they all got dress and went out to play. When time came for them to come in, they had a free play period and then got ready for lunch.
