General Comments							

Children were engaging in free play when I arrived for the start of the inspection. They were particularly interested in the play kitchen and play cleaning set. The operator assisted them in washing their hands before snack. Children brought snack from home and were actively offered water throughout the day. After snack the operator led a playdough activity and then drawing with the children. They returned to free play, showing interest in instruments and the pretend play stations. Play items are available in open cubbies at the children's

level.

Documentation was present in drawings that the kids made which were posted in the centre, photos of the children learning, and individual notebooks documenting milestones in literacy, social skills, and other accomplishments.

The operator discussed bringing in bins and coordinating the play items by type. The operator mentioned having photos of items on the bins to help the children with sorting items during tidy up.

Throughout the inspection the operator engaged with the children down on their level during play and during snack/meals. She supported children with handwashing and with meals. She prompted children to tidy up toys between transitions and encouraged sharing and positive peer interactions by celebrating their successes with this.

After lunch and diaper changes the children had their nap time. They napped for over an hour and then proceeded into their afternoon routine. They began with music play, then some free pretend play, and then puzzles.

All required files were observed to be well-organized. Daily information sheets were filled out and maintained in files after filled out.
