The washroom was clean and had soap and paper towel available for handwashing. All children washed hands after diapering was complete.

The kitchen floor was clean, the playpen set up in the nap room was clean, and the lower cupboard has been repaired.

The broken shelf has been removed and painting has been completed.

The operator has added a large variety of new materials, toys and resources to the space.

General Comments

The outdoor play space has been moved to the front yard. This is close to the road, so a fence was required. The operator installed fencing but due to the stairs of the home being repaired last week, a part of the fence on the side by the house is now missing. This must be fixed to ensure the safety of the children. While in the outdoor play space this morning, the operator was vigilant in having the children remain away from the opening in the fence and strategically placed herself to provide constant supervision.

The operator displayed kind and nurturing child guidance during the inspection. Children received hugs and comfort when sad. The operator provided a calm and smooth routine, diapering and getting ready for outside.
