- Indoor play area and equipment
- Safety
- Staff members records

The Quality Assurance Monitor observed the children eating their snack another group was observed playing in the gym area. The QAM also observed in one diaper changing area, two changing pad surfaces with small holes on the surface. The QAM had a discussion with the administrator and recommends that the 2 changing mats be replaced. The QAM also observed the children transitioning to lunch time (lunch box).

The QAM also observed an educator doing a smudge with the children. The educator also practiced numbers and colors in Mi'kmaq language.
