General Comments							
A monitoring Inspection occurred June 11, 2025.							
The children were observed in the play yard and Discovery Park.							
Educators shared that the children's current interests are cars, buses, hockey and water play. Outdoors, educators play an active role in facilitating children's activities.							
The indoor environments were observed, and opportunities are open for individual and group experiences. Various forms of literacy are present in the indoor environment. Several forms of documentation were observed throughout the facility. The rooms are set up and inviting. Books have been selected that reflect the children's interests.							
Monthly emergency evacuations are completed and posted. A clearly visible and prominent place is available to post the license, current inspection report, current monitoring reports and, orders for compliance.							
Traffic areas are kept clean and outdoor walkways are clean and free of clutter.							
Toxic products such as chemical products and cleaners are locked and inaccessible to the children.							
The changing area is located a meter or less from a sink. Diaper changing procedures are posted and visible to those completing a diaper change.

General Comments

Food brought from home is labelled with the child's name and refrigerated as required.

A conversation took place with the Operator regarding the strengths and needs for improvement of the facility. The strengths identified include: The room is set up and inviting, the materials invite the children to play. Many forms of documentation were visible throughout the facility and provided opportunities for both group and individual learning.

Areas where the facility can improve include, outdoor stationary equipment at Discovery Park to be checked during outdoor play to ensure swings and slides are surrounded by protective surfacing of appropriate depth. Wooden logs surrounding the sandbox at Discovery Park were splintered and posed a safety hazard. It was recommended that the children use the area adjacent for sand play. Ensuring daily attendance records are brought outdoors with the educators and ensuring water bottles are labeled and available to the children at all times.
