Comments: One staff has a first aid certificate that is not recognized on the Worksafe NB list of providers. QAM advised Administrator to ensure staff is not left alone with children until confirmation that this certificate is valid is obtained from WorkSafe NB or a new first aid certificate is obtained.			
30(3) An operator shall maintain the indoor play area of a licensed facility to ensure the safety of the children.	30(3)	May 24, 2024	
Comments: QAM notes that there is a hole in the drywall in the large bathroom. This hole must be repaired so that the wall can be properly cleaned.			
31(4) An operator shall ensure that the outdoor play area of a licensed facility (a) includes a shaded area that is at least 10% of the outdoor play area.	31(4)(a)	May 24, 2024	
Comments: There is not 10 percent shade at this time. The admin stated they would have sun sails to provide shade for the children, but they are not up yet.

Comments: QAM notes that there was no diaper changing procedure posted, but it was replaced during inspection. Deficiency is now compliant

QAM observed children arrive off the bus, enter the daycare, put on sunscreen, and go outside to play. Outside the children engaged in a variety of activities, and on entry they washed hands and ate their snacks of crackers and cheese.

General Comments

QAM discussed the small pool of water outside in the play area and was told that the children do not enter into the water.
