11(c)(ii) The qualifications and training requirements for administrators and educators are as follows: (c) at a full-time or part-time early learning and childcare centre, (ii) on and after July 1, 2020, (A) at least 50% of educators must hold a one-year Early Childhood Education Certificate or training that is equivalent in the opinion of the Minister, and (B) an administrator must hold a one-year Early Childhood Education Certificate or training that is equivalent in the opinion of the Minister.	11(c)(ii)	Jun 30, 2025	
Comments: During the renewal inspection, the Quality Assurance Monitor observed that the requirement for 50% of educators to hold a one-year Early Childhood Education (ECE) certificate or equivalent training was not being met under the current license. When this was brought to the administrator's attention, they confirmed that while more than 50% of the educators in the building do hold an ECE qualification, they are not currently distributed evenly across all licenses. The administrator informed the Quality Assurance Monitor that once the new rooms are approved, ECE-qualified educators will be reassigned to ensure all licenses meet the requirement.			
11.1(3) A staff member who works directly with infants or preschool children shall complete in each year 10 hours of training approved by the Minister related to the curriculum used at the designated facility.	11.1(3)	May 16, 2025	
Comments: During the renewal inspection, the Quality Assurance Monitor noted that not all staff members had completed the required 10 hours of professional learning. A discussion was held with the administrator to ensure that all required professional learning hours are completed for the upcoming renewal period.			
24(1) For the purposes of subsection 20(1) of the Act, the following records and documents shall be maintained on the premises of a licensed facility: (f) daily attendance records of the children on forms provided by the Minister.	24(1)(f)	Apr 10, 2025	Apr 10, 2025
Comments: During the renewal inspection, the Quality Assurance Monitor observed that the attendance sheet in one classroom had not been filled out accurately. Only 11 children were marked present, while 14 children were in attendance. The Quality Assurance Monitor brought this to the educator's attention, and the attendance sheet was updated immediately. Deficiency is now compliant.			

### General Comments

The Quality Assurance Monitor is on site to conduct the renewal inspection.  
The child-to-staff ratio is maintained throughout the visit.

## General Comments

During the inspection, the Quality Assurance Monitor observed various parts of the daily routine, including children eating snack, engaging in free indoor play, preparing for outdoor play, playing outside, having lunch, and resting during nap time.

A discussion was held with the administrator regarding the outdoor play area. The Quality Assurance Monitor noted that the sand around the swing and at the bottom of the slide needed to be raked. The administrator responded that additional sand would be added in the coming weeks and that the area would be raked in the meantime. The Quality Assurance Monitor also suggested adding more toys and materials to the outdoor space. The administrator confirmed that they are currently in the process of enhancing the outdoor play area with additional materials.
