<p>General Comments</p> <p>Licensing staff arrived at the facility to conduct the yearly license renewal inspection.</p> <p>The educators left shortly to meet the first group of children shortly after licensing staff arrived.</p> <p>When the first group of children arrived, some children went to have snack while other children engaged in free play activities. The educators were observed playing crib and a game of tag with the children.</p> <p>Licensing staff observed only positive child guidance throughout the inspection.</p> <p>Before the second group of children arrived at the licensed facility, the first group of children divided up into different groups to venture out into the community. One group went one way to a local park while another group wanted to challenge themselves to see how far up the hill they could walk.</p>
