Licensing staff arrived at the licensed facility to conduct a follow-up license renewal inspection. Upon arriving at the facility, children were engaging in free play activities. A small group of children were playing "monkey-inthe-middle." where two children were trying to successfully throw a soft ball to each other without two other children from intercepting the ball. Another group of children, located on the opposite end of the facility, were engaging in a serious game of basketball using a net, the children made out of cardboard from an earlier activity. The educators taped the cardboard net approximately 7 feet high on the wall for the children to throw a plush animal/doll in hopes of it going through the net. The third group of children were playing a game of cards with an educator.

The children were also observed eating their afternoon snack.

All staff and child files were complete with all of the required documentation.
