Monitoring Inspection:

Children and educators observed engaged in a variety of activities this morning including dramatic play, open-ended art, fine motor activities, and block play. Each environment is set-up with a variety of materials and

invitations for the children to explore.

Documentation, photos and learning stories are displayed throughout the environments that support the children's current interests (colours, jumping, animals, building, food and cooking).

Educators observed engaging in meaningful conversations with children at lunch time. Educators observed encouraging children to serve their own sandwiches. Chicken and vegetable soup and egg salad and tuna sandwiches were served for lunch. A vegetarian soup option was also available. English muffins and cream cheese were served for morning snack.

Preparation for nap time was observed today. Today was the Twos Room laundry day, their bedding was freshly laundered. Each room has a scheduled laundry day. Educators observed comforting children at nap time by rocking them or sitting with them and rubbing their backs.

Handwashing routines observed after outdoor play, after diapering and toileting and before lunch.

Monthly fire drills are documented.
