General Comments

A Monitoring Inspection was completed this morning. Infants - Child was observed sitting and eating snack with their educator, in the fenced in outdoor play area. Educator stated that present interests include books and balls. A discussion was had with educator regarding the outdoor play structures, and the possibility of removing some, to create a larger area to play and move around. 2/3 Group - Children were observed outside, playing in the sand box, playing in play structures, and filling and dumping containers of rocks. 2/3 Classroom - during diaper / toileting procedures, a child was observed leaving the 2/3 classroom, and briefly entering the infant classroom. The infant educator brought the child back to their classroom. A discussion was had with administrator, about the importance of keeping the inner doorways closed, especially during toileting procedures. 3/4 Classroom - Children were observed playing with babies, building with Lego, and mark making. Children were also observed cleaning up before snack, washing their hands, and eating their snack - banana, rice cakes, and peanut butter.
