General Comments

A Monitoring Inspection was completed this morning. The infants were observed dumping and filling baskets, and dancing to music. Educators were engaged with the children – sitting with and talking to the children at their level. The 2's group were observed sitting down, looking at books. Educator was engaged – sitting and talking to the children and asking the children questions about the pictures in their books.

Two / Three - Educators were observed helping the children get ready for outside play. Children were observed playing in the outdoor play area. Three /Four – Children were observed taking part in an arts and crafts activity that used colored ice cubes as paint. A conversation was had with operator regarding the infant outdoor play area. A second type of surfacing is to be added in the Spring. A conversation was had with administrator regarding storage room. This room is to be organized. A conversation was had with administrator regarding Arts and Crafts and how more open-ended crafts are required. A conversation was had regarding arts and crafts materials and how they are to be varied and in sufficient quantities, arranged on low, open shelves, and accessible to all children. Coloring books and sheets are not recommended in preschool classrooms.
