A Monitoring Inspection was completed this morning. Children were observed in their classrooms and in the outdoor play area. Infants were observed playing with each other and their educators on the floor. Infants were observed looking at pictures of themselves and classmates, which were in a new plexiglass holder, on the wall. While doing so, Infants were observed pointing to their friends, smiling, and talking.

Two / Three - Children were observed finishing their snacks and getting ready for outside play. Three / Four - Children were observed sitting in a group, singing songs, and counting. Educators were engaged with the children, singing along, and offering praise and encouragement. Educators were observed cleaning the tables, while the children were observed washing their hands before snack. Children were served fruit salad and crackers for snack. School Age Room - Children were observed eating snack. Children told QAM that they made Suncatchers this morning, and that after snack, they would be making Bird Houses. Educator stated that the group would be going sliding later in the day. QAM observed the 2, 3, and 4 year old children playing outside. Children were observed playing in the snow – making snowballs, pushing toy vehicles, rolling in the snow, and running. Educators were engaged – taking part in play, conversing with the children, and providing support and redirection when required.
